

DOCUSIGN ACCOUNT SETUP

An initial Account will need to be set up with DocuSign for PASS to be integrated to it.




DOCUSIGN TEMPLATES

Once set up, Templates are created within DocuSign which will have a PDC file with the text required within the document.

Mail Merge Objects are dropped onto the PDF which will be replaced with the Signature, Name and Date of Signing.


ASSIGNING DOCUSIGN TEMPLATES TO PASS REFERENCES

PASS is then configured with the Username, Password and Integration Key from DocuSign where all templates will be downloaded to the PASS eSignatures Library for assignment to a Reference Type.
